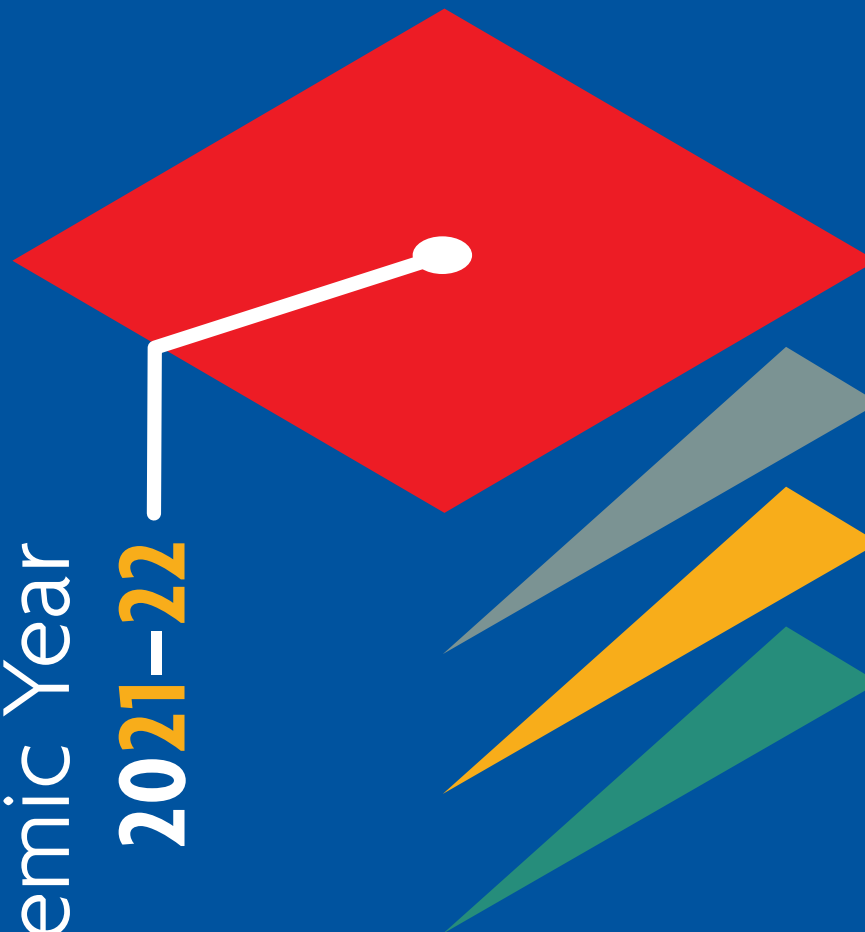

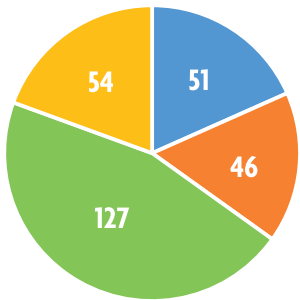
Participants are exposed to a mix of academic study and professional practice that are the “best fit” for diverse cultural backgrounds.

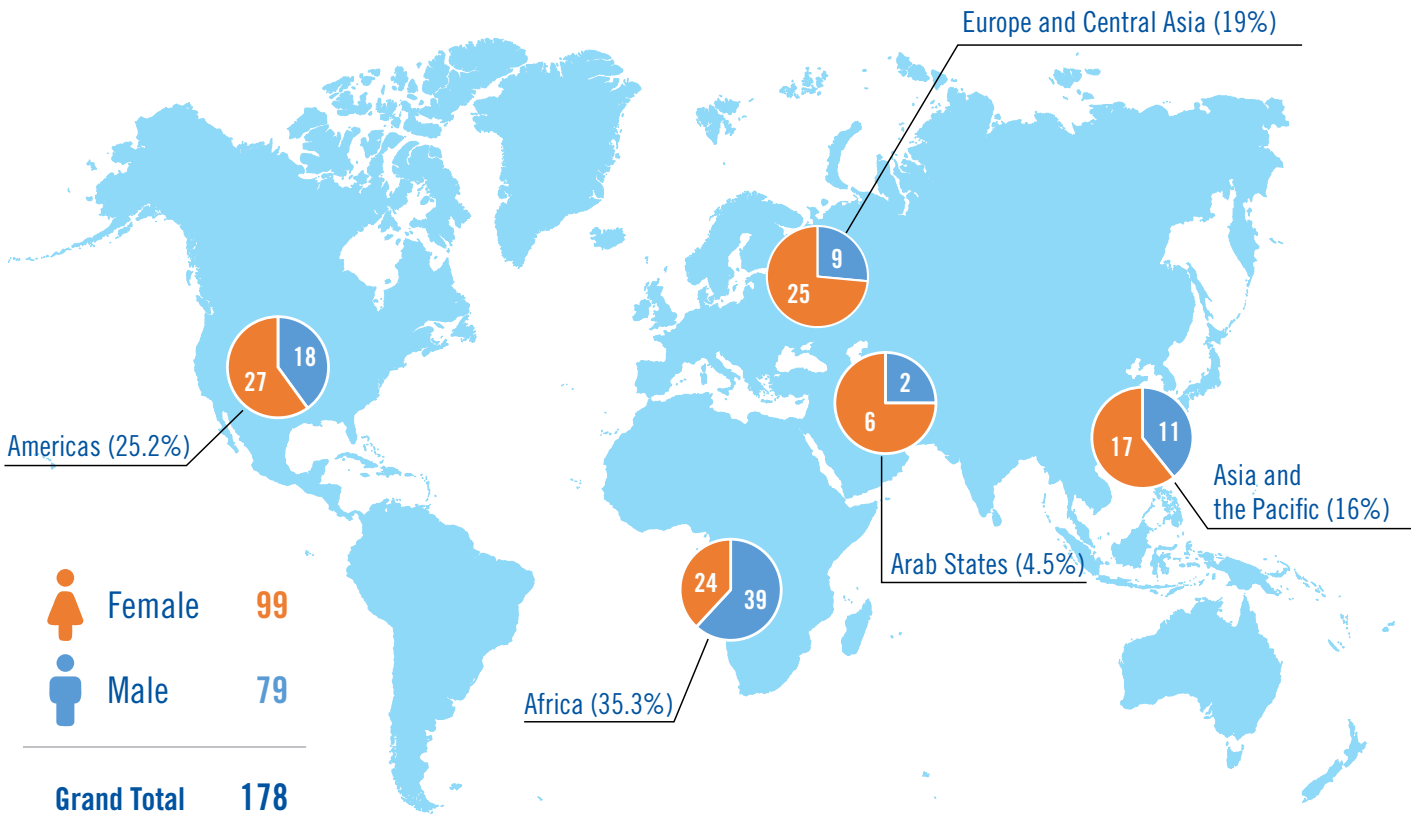

Master in International Trade Law



The Master aims to provide an in-depth understanding of the main legal issues concerning international commercial contracts, from contract drafting to dispute resolution, with emphasis on recent developments and the increasing complexity of contract law, including the impact of new technologies and the role of compliance for MNEs.

Moreover, it covers the key international institutional and legal frameworks for international trade and investment, and incorporates a dedicated module on international dispute settlement, international commercial arbitration and transnational domestic litigation.

This Master has been designed for recent university graduates who intend to work in the field of international trade law, in law firms, corporate legal departments, governments, international organizations, and academic or research institutions. Law consultants, practitioners, and young managers wishing to expand their knowledge in the field of international trade law had also taken part to the courses.

The 2021-2022 edition of the Master resumed its traditional learning model, which is mainly

based on intensive lectures on the ITCILO Campus in Turin. The new feature of this year's edition was the inclusion of the social dimension and technological innovation as new thematic areas within the three programme strands: private law, public law, and international dispute resolution. These new perspectives generated a high interest among the Master participants, especially the use of new technologies in international dispute resolution systems. Also for the next Academic Year, the Master objective will continue to provide participants with a diversity-oriented approach and a global perspective.

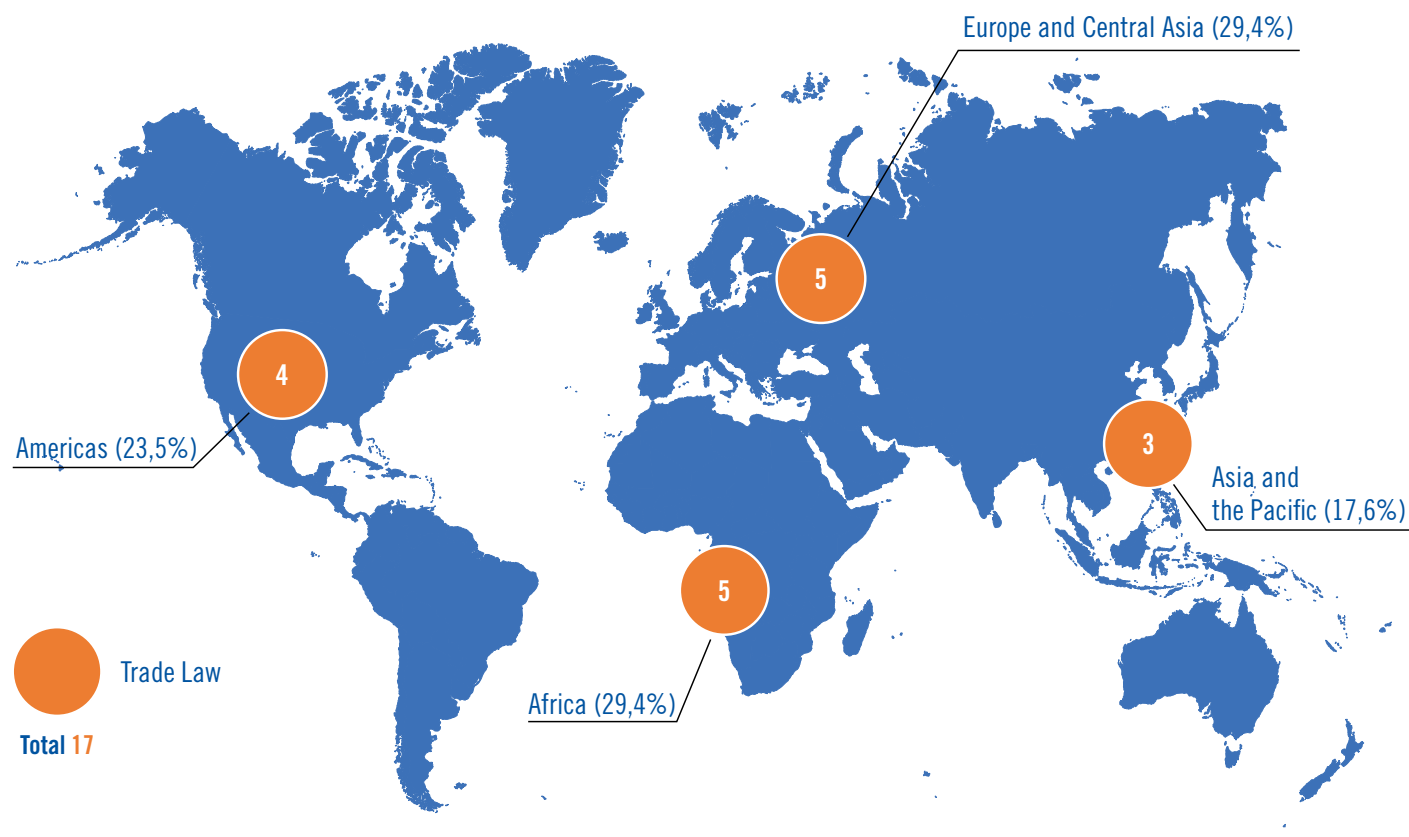

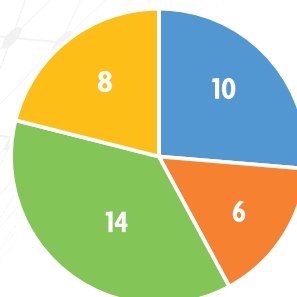

Master in Intellectual Property (LL.M.)



Intellectual Property (IP) law is facing unprecedented challenges. Emerging issues like artificial intelligence, big data, and biotechnological innovation raise questions related to the continuous need to define an optimal interface between law and technology. Similarly, IP law has become a crucial factor in economic, scientific, social and cultural policy.

In view of such, the LL.M. in IP attracts professionals from the public and private sectors as well as professionals and academics who wish to acquire the skills required to play a leading role in the practice of IP through a well-tested cross-disciplinary, international, and comparative law approach. The curriculum aims to provide an in-depth examination of traditional topics in IP law as well as a specialized analysis of the latest developments in the fields of patents, trademarks, copyright and related rights, trade secrets, industrial designs, e-commerce, and competition law. The diversified profile and backgrounds of participants and lecturers make the LL.M. in IP a truly international forum for discussion and exchange of knowledge, opinions and ideas that are entrenched in various legal systems.

The 2021-2022 edition of the Master Programme was delivered in a hybrid modality

allowing for both in-person and synchronous online participation. Throughout the Programme and in light of emergence from the pandemic, the issue of Global Public Health and access to medical innovations featured prominently in training activities and classroom debates. At the end of the training period, the Residential Phase of the Master culminated in the Annual Conference and Alumni Day, which focussed on the theme 'Intellectual Property, Resilience, and Recovery'.

Regional Distribution (ILO Regions) • 2021-2022

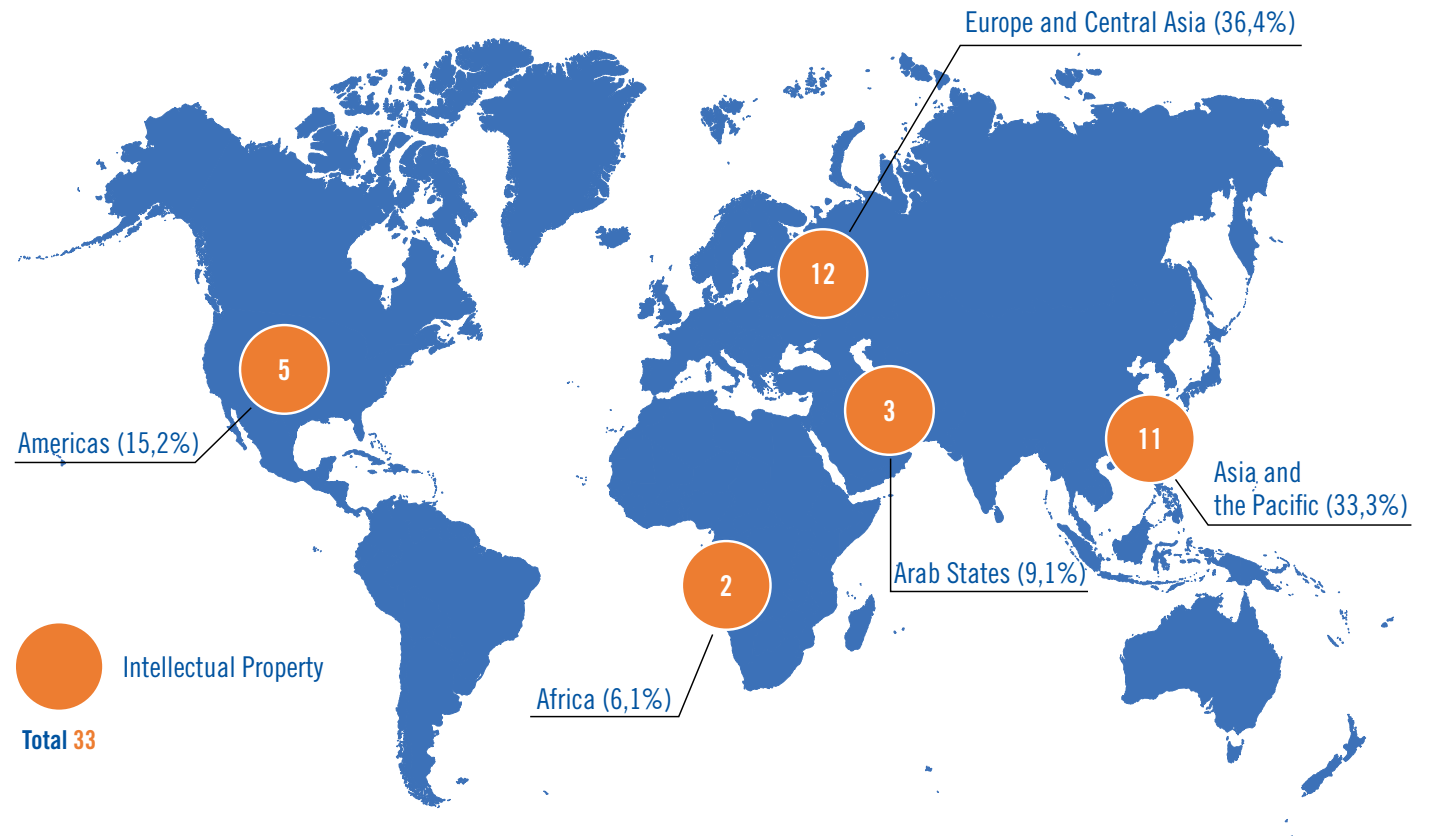

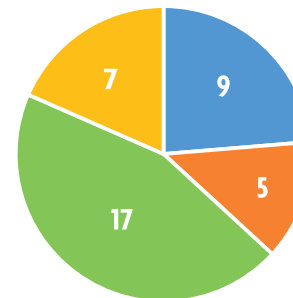

Master in Management of Development



The Master provides an opportunity to explore the theoretical, conceptual and operational frameworks for managing development from a multi-disciplinary perspective.

It integrates socio-economic policies with an in-depth understanding of the legal, institutional, local and managerial contexts for the effective planning and implementation of development programmes and projects. It thoroughly examines policies and strategies that may

contribute to sustainable transformations in terms of cultural, political, social, economic and environmental changes. The content and learning delivery methods are designed to provide the participants with the full spectrum of competencies needed to deal with the challenges currently faced by development professionals in their pursuit of social and economic progress, while preserving the natural environment for future generations.

The 2021-2022 edition of the Master in Management of Development was the nineteenth edition of the Master, and the third edition with the revised curriculum. The number of participants is in line with the previous year, with 17 participants from 14 countries. The Master combined two distance learning phases (an asynchronous phase of nineteen weeks and a synchronous phase of three weeks), and a face-to-face phase of eleven weeks. For the first time in three years, all participants attended the face-to-face phase

in person. Workshops and group activities made lectures highly interactive and lively. The synchronous phase of the online distance learning, on qualitative and quantitative methods applied to development field, was also highly appreciated. This edition was the first one in which Mandev could be delivered in the new format. Particular attention was paid to applied learning and interdisciplinarity and more time was devoted to the preparation of the final project. In addition to that, specific topics, such as introduction to public health, social and environmental justice have been added to the initial curriculum.

The face-to-face phase ended with the development of an original project, in peers; the Master end with a working paper, focused on theoretical reflections or assessing a specific case study.

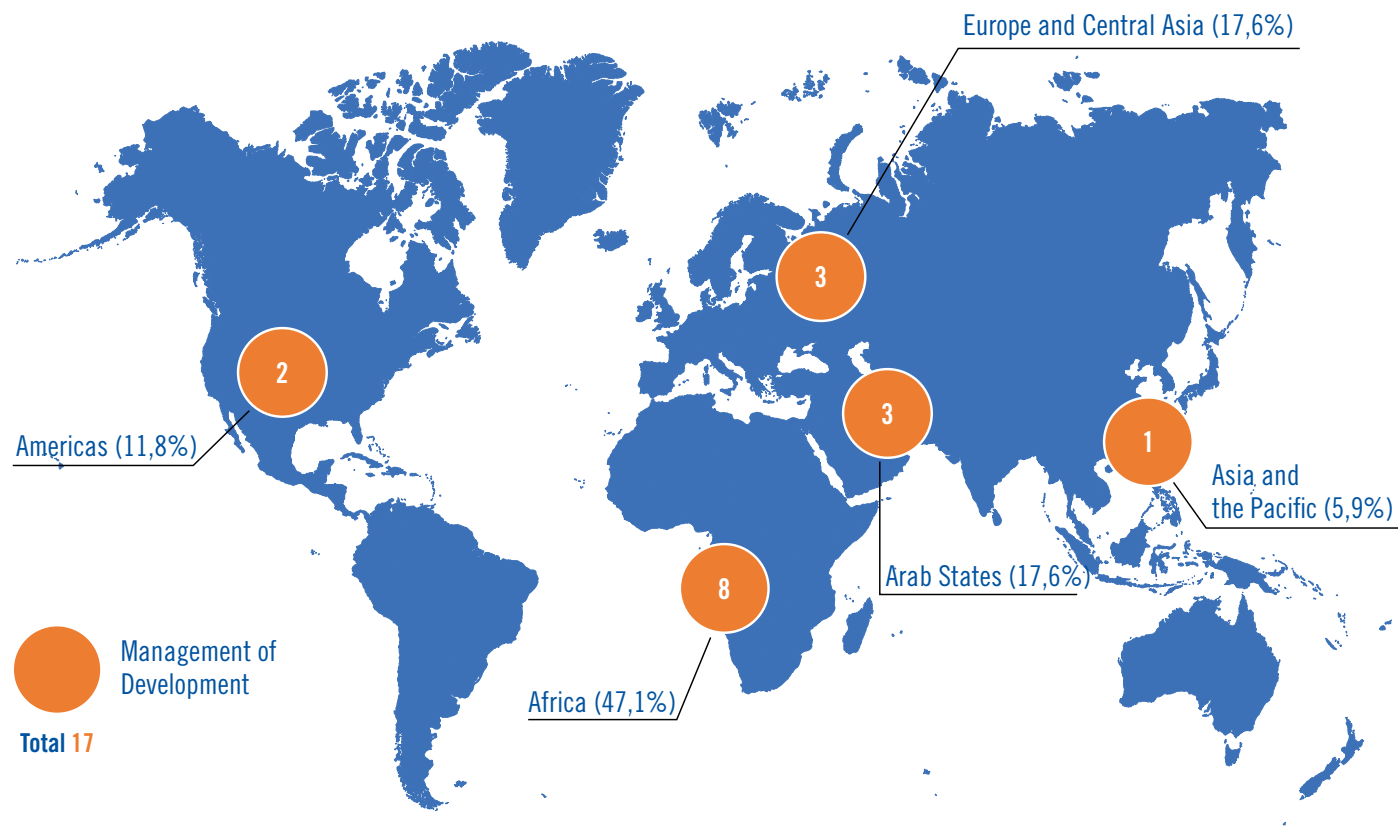
Regional Distribution (ILO Regions) • 2021-2022

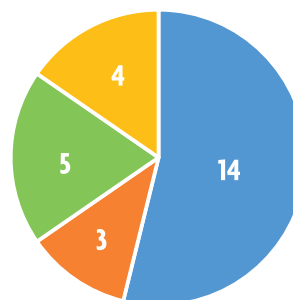

Master in Occupational Safety and Health



Public and private-sector organizations throughout the world are increasingly concerned with improving Occupational Safety and Health (OSH). In both developed and developing countries, the rapid pace of technological change, combined with the persistence of unsafe or environmentally hazardous working conditions, has served to focus attention on the need to create safe, healthy working environments and promote a new safety culture in the workplace. Organizations are increasingly

seeking OSH professionals who can catalyze these processes, and it is not always easy to find professionals with the right skills. Becoming a safety and health professional requires multidisciplinary training. The OSH profession calls for a broad-based educational background, including specialized knowledge of the physical sciences (medicine, physics, chemistry and engineering) and the social sciences (behaviour, motivation and communication), together with an understanding of the principles and concepts of management.

The Master combines the advantages of the academic knowledge and the international training experience of the organizing partners in the field of OSH.

The Master has been specifically designed for hygienists, physicians, chemists, engineers, inspectors, practitioners and officers, with a university degree but without a previous specialization in OSH, who are working, or wish to work, as OSH specialists.

The 2021-2022 edition of the Master Programme in Occupational Safety and Health was maintained as in the past, with the residential phase between January and the end of March, as in the pre-Covid era. A challenging issue, as it had been in the face-to-face phase of 2021, but in a different way, was the management - from the health point of view - of the arrivals and of the stay of the participants in Italy/on campus, almost all of them being from outside the EU, in a moment where in Italy some very strict rules applied due to the pandemic.

A major novelty regarding the curriculum was the introduction of specific topics/sessions/ study visits, related to health emergency management in the workplace (sessions on Covid 19 management in the workplace and on vaccination campaigns, visit to a vaccination hub), which were highly valued by the group of participants.

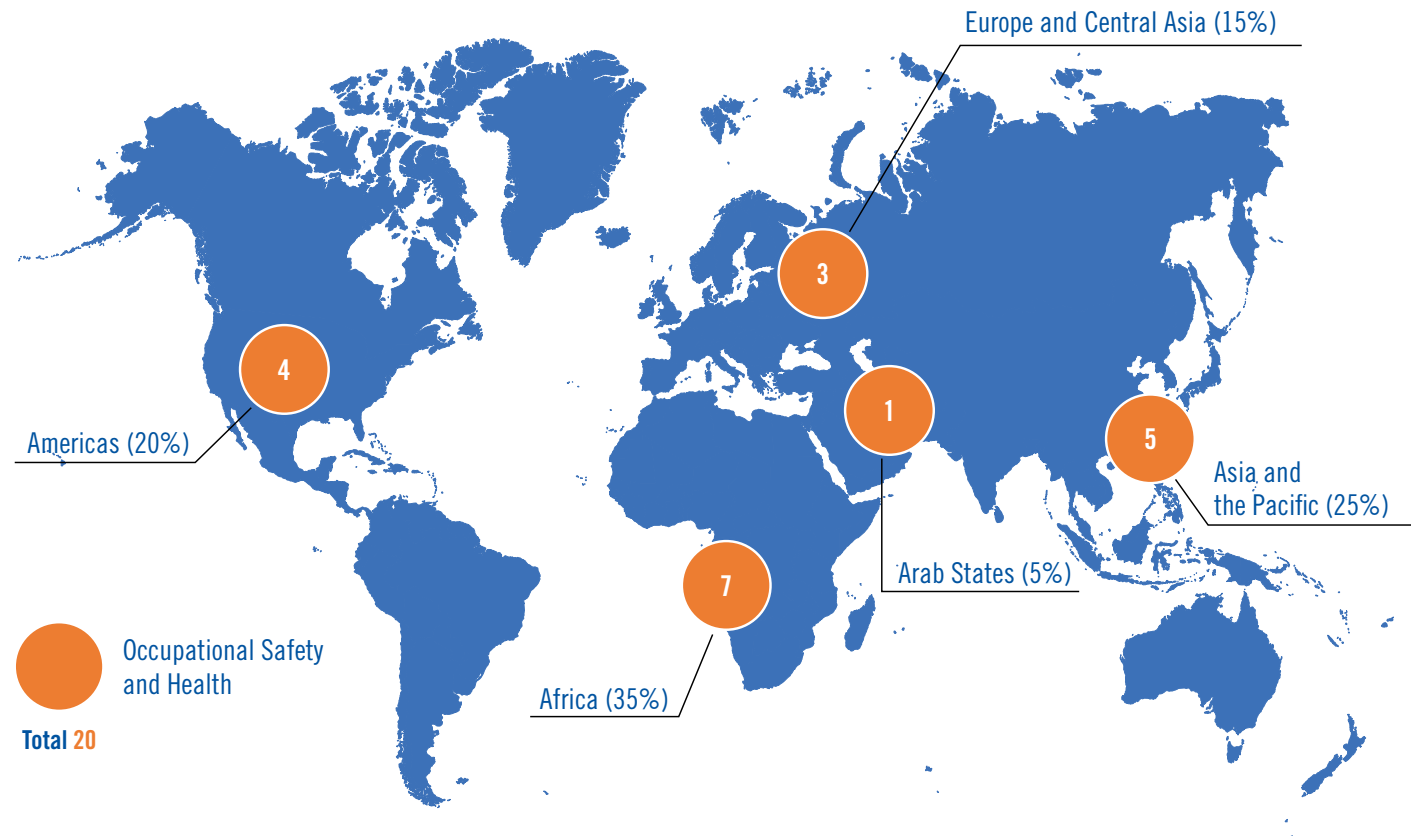

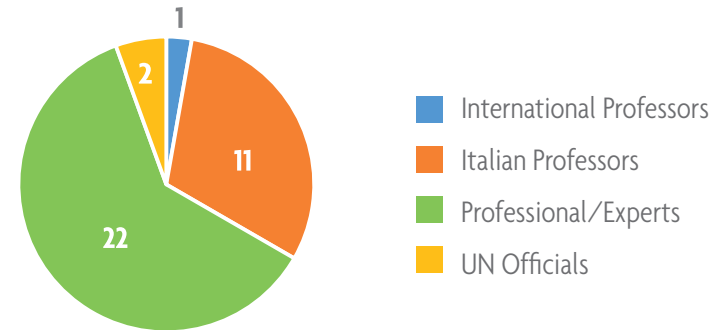

Master in Public Procurement Management for Sustainable Development



The Master in Public Procurement Management for Sustainable Development explores the legislative, regulatory, organizational and managerial foundations of a modern public procurement system. It aims to help make up the current deficit in qualified human resources and enable procurement professionals to cope with the challenges of regulating, executing and monitoring public procurement in an economic and socially responsive manner while mitigating adverse environmental impact.

Strategies and instruments for embedding social, environmental and human rights at the relevant steps of the procurement process/ supply chain are few of the key topics of the Master, together with the promotion of corporate social responsibility through public procurement.

Learning about the execution of the procurement process for goods, works and services (including innovative contracting modalities like public-private partnerships and e-procurement) is at the core of the Master's outcome whose participants are procurement trainers, procurement advisors and practitioners, local government bodies and public expenditure supervisory bodies as well as recent university graduates who intend to work in the field of public procurement or public expenditure management.

Striving to meet the changes and demands brought from the Covid-19 pandemic situation, the Master curricula has been newly enhanced in this 2021 – 2022 edition with lectures and

case studies on designing and conducting procurement operations in emergency and fragile situations: agile and smart design are the new skills and competences the Programme is focusing on. In addition logistics and supply chain issues related to more effective implementation with a focus on sustainability and inclusiveness. Red flags in Auditing procurement under emergency, the efficacy and value for money of procurement, the need for a better and strategic planning in public procurement, and the way forward in renegotiations in public private partnerships (PPP). The Master Programme, for the first time introduced weekly webinars with expert lecturers in the Distance Learning phase, in addition to the interactive techniques and tutor based briefings, which were already in place. This approach has been highly valued by the participants.

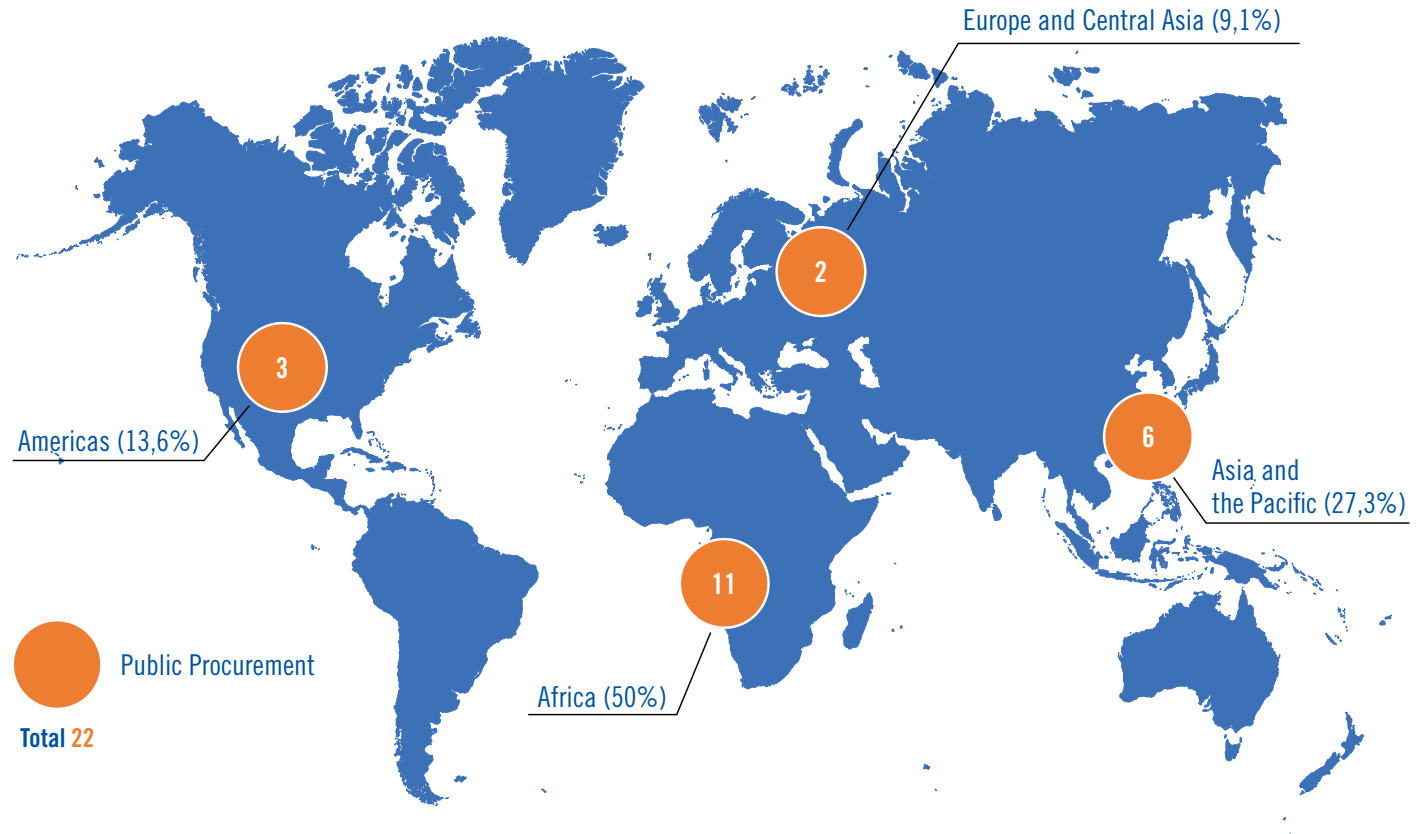

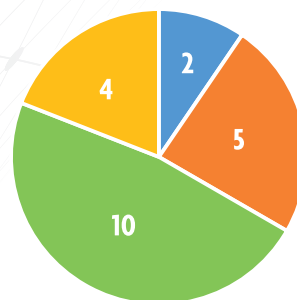

Master in Gouvernance et management des marchés publics en appui au développement durable



The Master Programme is aimed at active professionals who wish to specialize in the field of public contract management and who wish to occupy the following positions: procurement specialists; managers and executives of the civil service and local authorities responsible for the management of contracts; officials of national public procurement regulatory and supervisory bodies; auditors, project managers and public investment programmes; procurement

officers at international financial institutions; procurement consultants and trainers.

The objective of the Programme is to enable participants to acquire the entire body of knowledge and the technical capacities necessary for the regulation, award, execution, monitoring and auditing of public contracts. It refers to the national regulatory frameworks and procedures of the main international partners of the development: multilateral development banks, international organizations, specialized agencies. The Master harmoniously combines theory and practice both at the level of the regulation of public contracts and at the level of award.

The 2021-2022 edition was divided into three phases in order to face the consequences of the pandemic and its impact on travel, missions abroad and public health. The distance learning phase has favourably met the standards. It was especially appreciated by working participants

whom have been able to attend lectures despite the difficulties of this year. The second phase used to be full-time face-to-face in Turin. A hybrid modality was implemented for those who could not travel and then the distance learning in a virtual classroom. The research project phase were completed successfully through distance learning.

A reduced period of the face-to-face component delivered in Turin had an especially positive impact on visa application processes, costs and other bureaucratic arrangements. This new implementation guaranteed participant's satisfaction and the Master's comprehensive positive outcome.

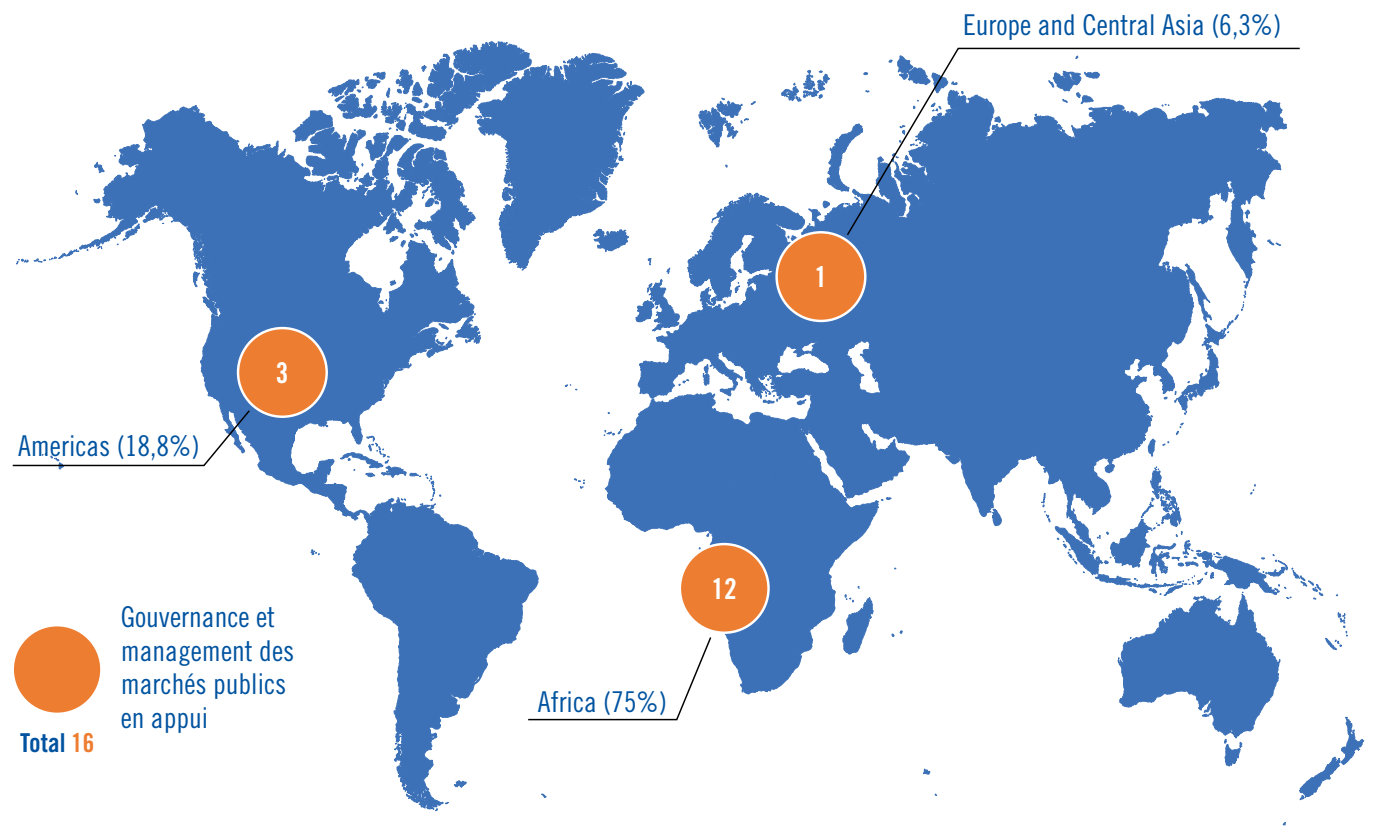
Regional Distribution (ILO Regions) • 2021-2022

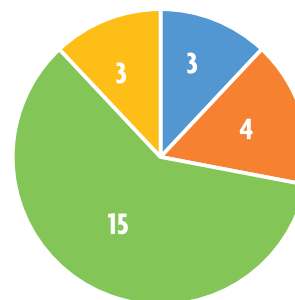

Therefore it has increased the number of international experts and the level of expertise among resource persons. It has also offered the possibility to working professionals to join the Master, seeking to deepen their knowledge in the field of industrial relations.

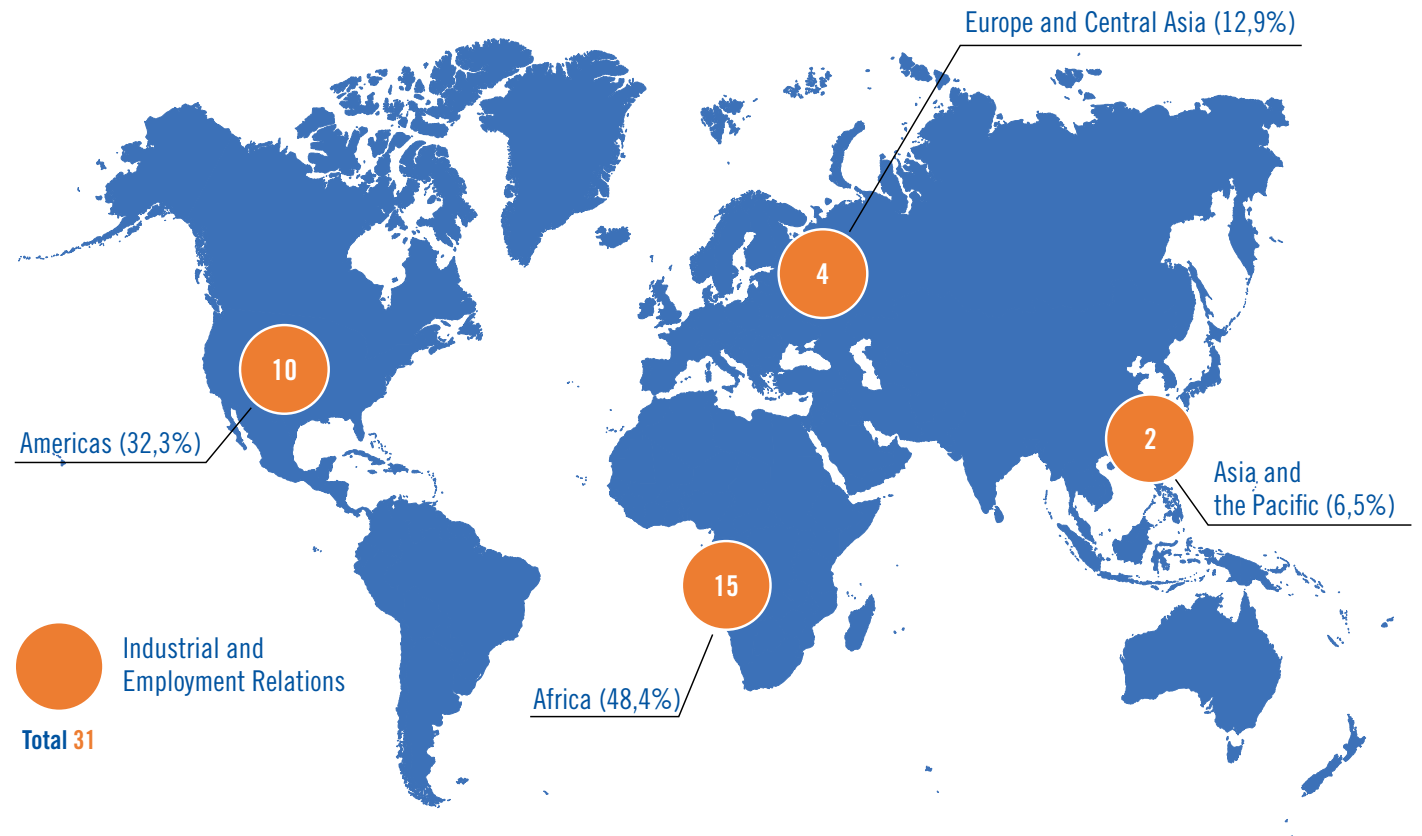
Regional Distribution (ILO Regions) • 2021-2022

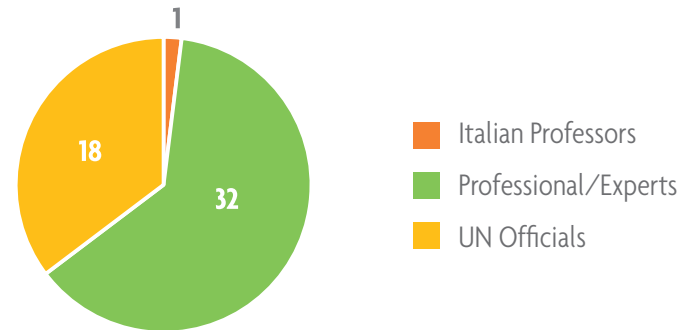

Master in Social Innovation for Sustainable Development



Social innovators and entrepreneurs are expected to play a crucial role in the implementation of the 2030 SDGs in the medium term.

Global trends show that, with the COVID-19 crisis, social exclusion, youth unemployment, migration, climate change and the problems of an ageing society are escalating. As they explore the implications of different models, participants acquire tools and techniques for anticipating change and responding to complex

situations in their respective fields.

Government agencies are encouraged to seek out “the best social innovations” in their programmes. The entrepreneurs of tomorrow are required to use their new models to achieve results and scale their services, including public-private partnerships.

The Master was intended for officials and/or professionals working in the public and private sectors and for UN agencies, foundations and NGOs; recent university graduates from developing and developed countries; people working or interested in social innovation and social entrepreneurship and related research; members of cooperatives.

The 2021-2022 edition of the Master in Social Innovation for Sustainable Development was the third edition of the Master. The course has seen an exponential increase in the number of participants in just three years, with 22 participants from 17 different countries, establishing itself as an internationally relevant

Programme. It combined two distance learning modules (a-synchronous and synchronous participation) with a face-to-face component, by making the Programme accessible and affordable for working practitioners and participants coming from all over the world. By merging theoretical and practical learning methodologies, this edition witnessed a greater focus than previous ones on extremely topical issues such as climate change, circular economy, entropy and energy transition. The Master course ended with the development of an original project linked to a specific environmental or social challenge and testable at the country or community level.

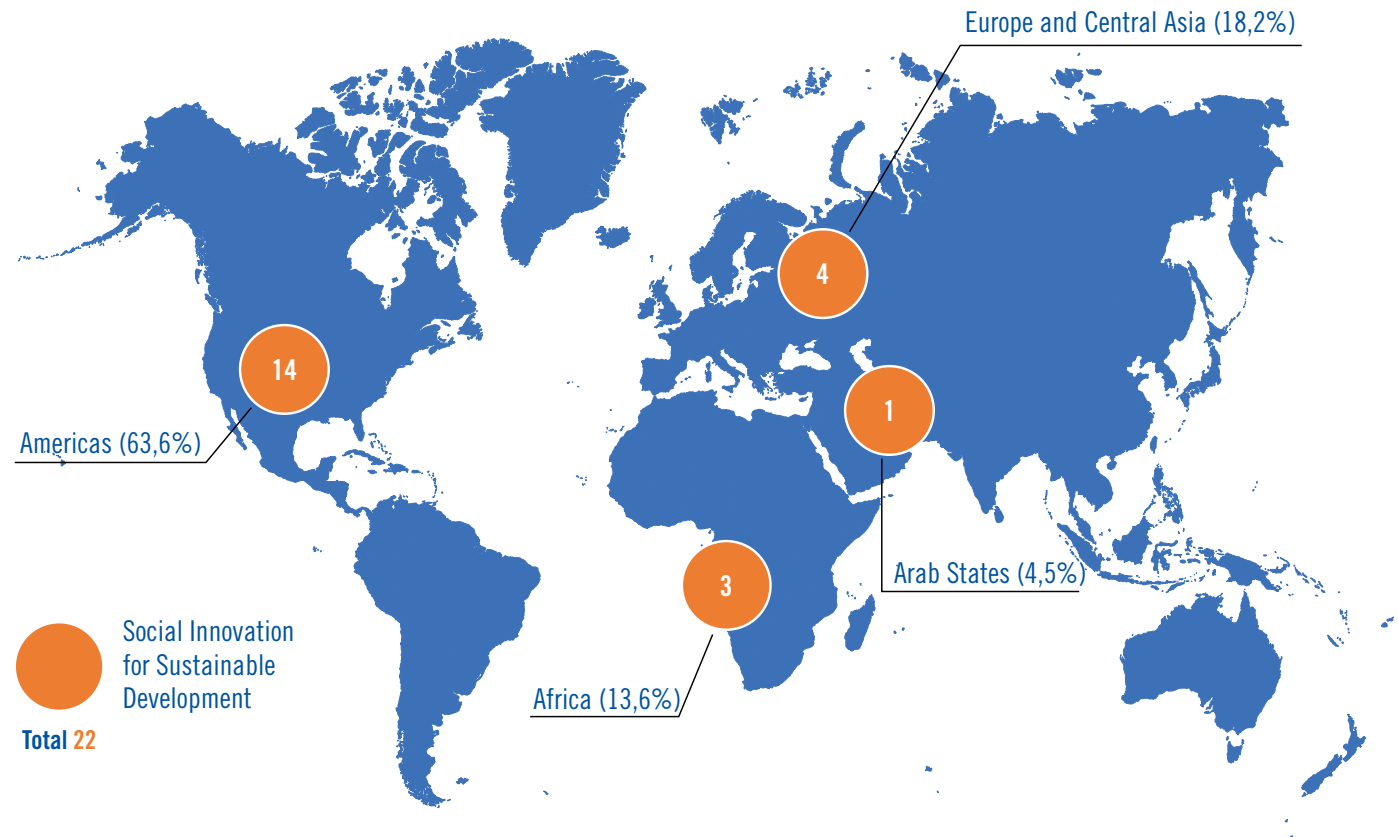
Regional Distribution (ILO Regions) • 2021-2022

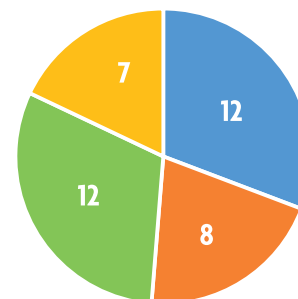
