# LABOUR ADMINISTRATION, LABOUR INSPECTION AND WORKPLACE COMPLIANCE ACADEMY

22 NOVEMBER - 3 DECEMBER 2021 TURIN, ITALY



## INTRODUCTION

In recent years, Member States of the International Labour Organizations (ILO) and the social partners have increasingly sought ILO's technical assistance to help strengthen their national labour inspection systems. These requests have often resulted in the provision of ILO's technical assistance to develop a comprehensive workplace compliance programme and possible model strategies that support the objectives of ministries of labour on compliance and deepen collaboration with the social partners. Different interventions have been made at the global, regional and country levels. In particular, the ILO has helped constituents develop their capacity to improve compliance at the workplace. Among other initiatives, the ILO is working with constituents to design innovative and complementary approaches to workplace compliance, including in the informal economy. The COVID-19 pandemic has created serious challenges in the world of work. The current crisis is a unique opportunity to reassess the central role of Labour Inspection in the recovery path to promote productive, fair and healthy workplaces.

The Academy will provide participants with a unique opportunity to gain new insights, share experiences and reflect on key issues, trends and challenges relating to workplace compliance through labour inspection. The Academy will also address the needs and responses of governments, both in the short-term scenario of the pandemic and post-pandemic COVID-19, and in improving the labour market governance and the Occupational Safety and Health (OSH) in the medium and long term.

The Academy will be organized by the ILO LABADMIN/OSH Branch<sup>1</sup> of the Governance and Tripartism Department of the ILO jointly with the International Training Centre of the ILO (ITCILO).

- Apply a specific labour inspection methodology to the informal economy
- Describe successful experiences for undertaking the inspection of psychosocial factors
- Evaluate the feasibility of applying new tools, recruitment and training strategies information and communication technologies, and strategies in the labour inspection system.

## **METHODOLOGY**

The Academy will begin with access to the Internet-based learning platform of the ITCILO that will be activated before the face-to-face sessions. In this platform, participants will be able to access a documentation center that will contain reference materials on the topics of the Academy so that participants can become familiar and expand their knowledge of specific subjects of the Academy. Access to this platform and its resources will remain open after the Academy.

A participatory approach will be used, building on the knowledge and practical experience of participants, allowing the content to be oriented to their interests and needs. Presentations by experts, discussions, exercises, case studies and group work will be adopted throughout the sessions of the Academy. It will combine plenary sessions with elective parallel sessions and elective workshops.

The resource persons that will deliver the training will be selected based on their professional experience and knowledge of the subjects.

An initial and final evaluation will be carried out in order to evaluate the degree of acquisition of knowledge. On the other hand, the interest and usefulness of different topics, resources and activities developed during the course, as well as presentations,

teaching materials and the methods used and, above all, the scope of the proposed objectives will also be evaluated. The ITCILO will issue a certificate of participation to all registered participants who attend at least 80% of the face-to-face sessions of the course and who take the requested evaluation tests.

# **LANGUAGES**

Simultaneous interpretation will be provided in English, French, Arabic and Spanish in all plenary sessions. Translation into Arabic, French and Spanish will be available only in selected elective parallel sessions and workshops.

## APPLICATIONS AND FEES

The participation cost in the Academy (3,795 Euros) is payable in advance by the participant or his or her sponsoring organization includes:

- Tuition, training-related documentation and use of ITC/ILO Campus facilities;
- Single-room accommodation at the ITC/ILO campus, full board and emergency medical care and insurance.

Please note that airfares are **not** included.


