WHAT

WHAT TOPICS DOES THIS ACADEMY COVER?

This intensive five-day training course will cover:

- The five categories of FPRW, and their interconnected and mutually reinforcing nature
- Innovative approaches to combating violations of FPRW
- Decent work, Social Inclusion, and cross cutting strategies for the integration of all FPRW
- Strengthening sustainable supply chains.
- Tackling emerging global challenges such as the digital transformation of labour markets, ensuring decent work in new forms of employment, and advancing occupational safety and health as a key human right.
- The role of governments, employers, and workers' organizations in advancing FPRW through robust frameworks and systems.
- The role of ILO supervisory mechanisms as powerful tools to detect gaps in the realization of FPRW.

WHAT WILL I LEARN?

The Academy will offer master classes and elective sessions on:

- Tools to combat forced labour and trafficking in persons
- The elimination of Child labour and the latest global estimates
- Enhancing freedom of association and the effective recognition of collective bargaining.
- Strategies to promote inclusion, diversity, and non-discrimination in the workplace.
- Approaches to integrate FPRW into national policies, supply chain governance, and business strategies.
- Practical approaches for strengthening Occupational Health and Safety (OSH) as part of FPRW.

¹ There are five categories of Fundamental Principles and Rights at Work: freedom of association and the effective recognition of the right to collective bargaining; the elimination of all forms of forced or compulsory labour; the effective abolition of child labour; the elimination of discrimination in respect of employment and occupation; and a safe and healthy working environment.

By the end of the Academy, participants will be equipped to:

- Develop and enforce integrated policies promoting the realization of FPRW
- Implement strategies to integrate FPRW into diverse sectors and labour markets
- Understand the ILO supervisory mechanisms for detecting gaps in the realization of basic human rights in the world of work
- Address and mitigate risks in supply chains, ensuring FPRW for all workers

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
