The participation fee, excluding international travel costs, is **EUR 4,100**, payable in advance by the participant or their sponsoring organisation. This fee covers tuition, access to the eCampus platform, use of training facilities and support services, course materials, accommodation and full board at the Centre's Campus, and emergency medical insurance.

Cancellation of participation in regular courses will result in the following penalties:
