To respect workers' rights in your operations or supply chains, it is essential that companies have a solid understanding of those rights. This course provides participants with the expertise, tools, and knowledge they need to improve their skills in the field of labour-related human rights and core elements of effective HRDD.

WHAT

WHAT TOPICS DOES THIS COURSE COVER?

This course is designed for professionals who want to link three key topics in their work:

- International Labour Standards
- Responsible Business Conduct
- Human rights due diligence as described by the UN Guiding Principles on Business and Human Rights

WHAT WILL I LEARN?

Participants deepen their knowledge of the key topics with the guidance of international development experts.

- **Fundamental Principles and Rights at Work**, including the fundamental right to a safe and healthy working environment
- Conditions of work, including **working hours and wages**
- A comparative overview of leading **international frameworks** such as the ILO MNE Declaration, the UN Guiding Principles on Business and Human Rights, and the UN Global Compact
- Best practices in human rights due diligence by companies from different **geographical, sectoral, and operational contexts**

WHAT WILL I BE ABLE TO DO?

Participants advise and lead businesses and institutions toward integrated labour rights-related due diligence frameworks.

- Analyse international RBC instruments and frameworks **through the lens of the International Labour Standards**
- Optimize your organizational or company level HRDD processes to promote and respect workers rights in your own operations and supply chains
- **Access** ILO database, tools and resources

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
