OVERVIEW

This course is designed for senior professionals and policymakers in the field of social protection who seek to address the evolving landscape of the labour markets. As digital platforms, gig-work and non-standard employment models reshape the world of work, the need for executive and innovative social protection strategies that are both inclusive and adaptive is gaining a priority.

The course aims to provide insights to challenges and opportunities that the new forms of work present, guiding participants through policy design, implementation as well as administrative and IT solutions. By exploring case studies and emerging practices, participants will be versed into the forward-looking solutions for social protection frameworks that ensure protection for all, regardless of the employment status.

- Explore innovative legal, institutional, and technological approaches to extending social protection to all workers, including those with multiple employers or unclear employment status.
- Gain practical insights into administrative innovations, regulatory and governance frameworks at national and international levels influencing platform work and social protection innovation.
- Reflect on the role of employment classification, contributory mechanisms, and portability of entitlements.
- Learn to assess effectiveness, equity, and sustainability of executive-level social protection solutions for emerging labour forms.

- Identify key challenges and opportunities in expanding social protection coverage for workers in non-standard and digital employment settings.
- Assess the relevance of international labour standards and recommendations for your national system.
- Draw lessons from comparative practices and adapt insights to your organization's or country's strategic priorities.
- Recognize entry points for legal or institutional reform that improve inclusiveness and adequacy of protection.
- Reflect on financing strategies and the use of digital technologies in benefits administration.
- Strengthen your ability to engage in informed dialogue with stakeholders and formulate ideas for collaborative, cross-sectoral approaches to policy adaptation and innovation.

This course is eligible for the Diploma For Social Protection Managers. To achieve the Diploma, successful candidates must complete four eligible courses within a five-year period and undertake a capstone assessment.

WHO

WHO TAKES THIS COURSE?

The course is designed for executives, managers, planners and other professionals committed to building universal and comprehensive social protection systems, ensuring that no one is left behind. It is intended for a range of professionals from both the governmental and non-governmental sectors, including employers' and workers' organizations. This course will be equally beneficial for professionals from the UN agencies, civil society organizations, research institutes and consultancy firms.

HOW

The course consists of 60 total hours of learning, broken up into three phases.

- **Pre-course (10 hours):** Self-guided study through the online eCampus platform. Includes a pre-course assessment.
- **Residential week (45 hours):** 5-day intensive training at the ITCILO in Turin.
- **Post-course assignment (5 hours):** Individual assignment putting the gained knowledge into practical perspective.

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
