# INTRODUCTION/BACKGROUND

Given the recent outbreak of the COVID-19 pandemic, many national statistical offices and other national and international data producers have been facing obstacles to carrying out their work as usual. There is a need to reflect on these challenges and to identify solutions that enabled data producers to continue doing their work in line with international statistical standards and best practices despite the pandemic. Moreover, it is useful to understand how the COVID-19 response experience could support the modernization of labour market data collection systems around the world. With this in mind, the ILO Department of Statistics, in collaboration with the ITCILO, is organizing this course for data producers and users. It offers a great opportunity to reflect on the ongoing challenges, to learn about the latest international statistical guidance on production and use of data during the pandemic, and to display innovative solutions to overcoming the COVID-19 data collection disruptions.

## LEARNING OBJECTIVES

The main objective of the course is to equip national and international stakeholders with the necessary competencies to:

- Adjust data collection tools and processes as to maintain the production of work statistics during the pandemic, following the latest international standards;
- Produce relevant statistics to capture the impact of COVID-19 on participation in different forms of work (paid and unpaid);
- Interpret correctly the evolution of the main labour market indicators during the crisis.

More specifically, the course aims to:

- Review the main data production challenges faced during the pandemic and solutions identified;
- Explain the relevance of the ICLS standards to monitor the COVID-19 impacts;
- Familiarize with rapid surveys, alternative data collection tools to capture COVID-19 impacts on the world of work;
- Promote the measurement of unpaid work and telework, two priority topics during the pandemic;
- Highlight the importance of modernizing labour market data collection systems as to make them more resilient

# TARGET AUDIENCE

The course targets:

- Labour Statisticians/officials from national statistical offices; Ministries of labour and related institutions (such as labour observatories); Other Ministries or Government institutions engaged in employment and analysis or involved in the collection and analysis of labour market information;
- Employment and development policy analysts, research and academic institutes, in addition to International organizations and Donors engaged in capturing COVID-19 impact;
- Representatives of workers' and employers' organizations.

# ONLINE COURSE CONTENT

The course is structured around three main modules:

## **Module 1** Introduction to course and impact of COVID-19 on the world of work/ Maintaining labour market data collection during the COVID-19 pandemic

- The impact of COVID-19 on labour markets: key findings from the ILO Monitor
- Key indicators and data requirements for measuring and monitoring COVID-19 impacts on the world of work
- Overview of main challenges and solutions
- Importance of data quality assessment to support good communication of results

## **Module 2** Capturing and monitoring COVID-19 impacts on the world of work/ Priority issues during the pandemic

- Relevance of the ICLS standards
- Rapid surveys
- Telework, remote work and work at home
- Unpaid work

## **Module 3** Lessons learned and good practices, innovations for the future of labour statistics

- COVID-19 experience: from crisis response to development of modern and resilient labour market data collection systems
- Examples of national development plans
- Way forward

## WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate.
