WHAT TOPICS DOES THIS COURSE COVER?

This course is based on methodologies, tools, and approaches developed by the ILO and its partners to forecast jobs creation and evaluate outcomes.

- The **ILO approach** to jobs measurement and employment impact assessment
- **Decent work indicators** and their use according to the **theory of change**
- **Ex-ante** versus **ex-post** impact analysis: a wide array of methods
- **Designing** an employment impact assessment **plan**
- **Evidence uptake** in policy formulation

WHAT WILL I LEARN?

Participants will learn how to measure the quality and quantity of jobs and how to assess employment impacts of economic, sectoral, trade-related and labour market policies.

- Indicators and methodologies for measuring quality and quantity of jobs
- Theoretical background and empirical applications of a wide array of impact assessment **methods**:
 - Input-Output Tables and Social Accounting Matrices
 - Sectorial identification
 - Randomized Control Trials
 - Quasi-experiments
- All about **data** needs and collection tools

WHAT WILL I BE ABLE TO DO?

- Develop a theory of change and select indicators to measure job-related outcomes and impact
- Identify the **most suitable method** to assess a given type of employment promotion intervention
- Design Employment Impact Assessments that consider both the **quantity** and **quality** dimensions of employment, as well as the needs of **vulnerable groups** as youth, women, rural populations and informal workers.

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES
