WHAT

WHAT TOPICS DOES THIS COURSE COVER?

The course will teach the competencies needed to make informed decisions about how to measure and evaluate the results of interventions to promote decent jobs for women and men, with focus on vulnerable groups such as youth, rural populations and informal workers.

The content provided will build on the methodologies, tools, and approaches developed by the ILO and its partners to forecast jobs creation and evaluate outcomes, such as:

- The **ILO approach** to employment impact assessment, including impacts of pandemics like COVID-19
- **Employment indicators** and their use according to the **theory of change**
- **Ex-ante** and **ex-post** impact analysis: a wide array of methods
- **Evidence uptake** in policy formulation.

WHAT WILL I LEARN?

- How to assess employment impacts and close evidence gaps
- Theoretical background and empirical applications of a wide array of impact assessment methods, such as:
 - The new ILO nowcasting model used to assess employments impact of COVID-19
 - Input-Output Tables and Social Accounting Matrices
 - Local Multipliers
 - Sectorial Decomposition Analysis
 - General Equilibrium Models
 - Randomized Control Trials
 - Quasi-experiments

- All about **data** needs and collection tools (including real-time data)
- All about **institutional capacities** needed.

WHAT WILL I BE ABLE TO DO?

- **Plan and manage** Employment Impact Assessments, from timeline definition to dissemination of findings
- Identify the **most suitable method** to assess a given type of employment promotion intervention
- Design Employment Impact Assessments that consider both the **quantity** and **quality** dimensions of employment.

HOW DOES THE PROGRAMME WORK?

The course consists of a series of online modules which include weekly webinars and exercises. The modules are accessible through ITC-ILO eCampus platform and are meant to be completed over a period of six weeks, from 12 September to 21 October 2022.

- This e-learning course consists of a **blend of online resources**, live webinar sessions led by ILO specialists and ITCILO experienced trainers, individual and collaborative group exercises using our eCampus platform.
