OVERVIEW

SNAPSHOT OF THE COURSE

This 4-week online course looks at the potential of enterprises to contribute to the achievement of decent work for all, a universal goal recognized in the 2030 Agenda for Sustainable Development. It provides a comprehensive introduction to the ILO Tripartite Declaration of Principles concerning Multinational Enterprises and Social Policy (MNE Declaration), and touches upon issues related to Business and Decent Work, Responsible Business Conduct (RBC), sustainable investment and trade and social dialogue amongst others.

WHO ATTENDS THIS COURSE?

The course is designed for representatives of governments and employers' and workers' organizations responsible for socio-economic development, trade, or with a demonstrated interest in policies related to socio-economic development, foreign direct investment and responsible business and operations of multinational enterprises. This course is also of particular interest for professionals working on labour rights related RBC.

Course learning materials and tuition will be offered online in English. The following requirements are therefore essential to participate in this course:

- The ability to use a computer with the internet access
- Good knowledge of written/spoken English

WHAT WILL I LEARN?

Participants get up-to-date information, as well as the chance to interact with peers and the ILO staff on:

- How the MNE Declaration can support governments, employers' and workers' organizations in their policies and strategies to encourage the positive contribution of business to decent work and minimize and resolve potential negative impacts of business operations
- What is the aim, approach, principles and operational tools of the ILO MNE Declaration
- What actions governments, employers' and workers' organizations can take to mobilize enterprises for the realization of decent work

WHAT WILL I BE ABLE TO DO?

- Advise on policies, strategies and actions to maximize the positive contribution of MNEs to economic and social progress (foreign direct investment and global supply chains)
- Understand the different roles of governments, employers' and workers' organizations, and enterprises in promoting inclusive, responsible and sustainable business practices

HOW

HOW DOES IT WORK?

The course will be offered online through the ITCILO eCampus over a period of 4 weeks from 12 September – 7 October 2022, for an estimated total of 36 learning hours.

The course consists of three components:

- Self-guided learning: Flexible self-guided online learning on eCampus, anytime and anywhere.
- 'Real time' learning: Technical learning webinar and engaging video presentations by highly experienced trainers are programmed twice a week. These sessions provide for an opportunity to interact with experts and co-participants directly.
- Assignments: Short and task-oriented assignments including a final course assignment to be completed as preparation or follow up to the learning webinars and in order to receive the final certificate of participation. Participants will receive a written feedback on final assignment.

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
