OVERVIEW

SNAPSHOT OF THE COURSE

The COVID-19 crisis has reversed 15 years of progress in reducing youth NEET rates. In 2022, almost one in four (23.3 per cent) of all young people around the world were not in employment, education or training (NEET). The 289 million young people who were in this situation missed out on a crucial early stage of their personal development and risk facing severe disadvantages in the labour market in the future. Young women are more likely than men to be NEET globally, and in some sub-regions (Arab States, North Africa, South Asia) the gender gap is extreme. Addressing the challenges of youth NEETs requires a continuum of education, employment and labour market, and social policies and programmes that need to be coherently integrated in employment frameworks.

This course, organized in collaboration with the ILO's Employment Policy Department, provides a platform for sharing of knowledge and experience of policy approaches and instruments for reducing the NEET rate. Join us on line to start innovating on the responses to the challenges of youth NEETs in your country.

WHAT

WHAT TOPICS DOES THIS COURSE COVER?

This course presents global and regional overviews of trends, challenges, and opportunities regarding young NEETs.

- **Characteristics** of young NEETs and circumstances underlying their status
- **Policy approaches** and responses to the challenges using a diversity of instruments
- **Good practices** in the implementation of comprehensive and integrated approaches

WHAT WILL I LEARN?

This course provides the knowledge and tools professionals need to approach youth NEET-related issues in a holistic way.

- All about the **sub-groups of young NEETs**, as well as potential risk factors
- How to utilize **policy instruments**, including:
 - Early intervention strategies to reduce early school leaving and skills mismatches
 - Outreach strategies to identify and provide support to detached youth
 - Profiling tools to inform the provision of targeted services, including job search assistance, guidance and counselling
 - Placement offers, being in education, training or labour market
- What **works best in tackling labour market and social barriers** to the integration of young NEETs
- Lessons learned from the **European Youth Guarantee** and other comprehensive approaches

WHAT WILL I BE ABLE TO DO?

This course aims to empower participants in analysing country-specific situations, designing and implementing effective policies to reduce the NEET rate.

- Understand the **determinants and the persistence** of young NEETs
- Recognise how the diversity of NEETs calls for **policy coordination** within the mutually reinforcing areas of education, employment and social policies

- Design **programmes and policy responses to reduce the NEET rate**
- Develop solutions to address the persistent **gender differences** in the NEET rate
- Monitor and evaluate **existing and new** interventions

HOW

HOW DOES THE LEARNING JOURNEY LOOK?

The learning journey consists of four weekly modules offered through the eCampus online platform to be completed over a period of four weeks, for an estimated total of 20 learning hours.

- **Module 1.** Understanding the diversity of NEETs
- **Module 2.** Preventing young people from becoming NEETs
- **Module 3.** Preparing young NEETs to seize *EET* opportunities
- **Module 4.** Delivering and monitoring quality *EET* offers to NEETs
