SNAPSHOT OF THE COURSE

The **Digital Governance Academy** is an innovative capacity-building programme developed under ITCILO's Social Protection, Governance and Tripartism (SPGT) umbrella. It equips institutional leaders, senior policymakers, and technical specialists working in key areas of public governance with the strategic foresight and technical knowledge to harness digital transformation for improved governance and service delivery. This flagship training course will focus on the adoption of the latest digital technologies in key areas such as:

- **Labour Inspection**
- **Labour Migration**
- **Social Dialogue**
- **Social Protection**
- **Occupational Safety and Health (OSH)**

The Academy is structured as a transversal, multi-disciplinary initiative with a wide range of electives offering a tailored learning journey for practitioners in a Digital Era. Participants will explore the institutional, legal, and technological dimensions of digital transformation, including data governance, leveraging artificial intelligence, leading automation processes, and addressing cybersecurity and privacy concerns.

- **Using data as a strategic asset** through real-time dashboards, case-management, and evidence-based policy feedback loops.
- **Leadership skills** to drive digital change, foster innovation, and overcome resistance within institutions.
- **International governance frameworks** and institutional maturity models to successfully lead digital transformation initiatives.
- **Ethical and legal safeguards** for responsible adoption of disruptive technologies.
- **Cutting-edge applications of artificial intelligence** for predictive analytics, enhanced transparency, and a more efficient service delivery.

WHO

WHO TAKES THIS COURSE?

The Digital Governance Academy welcomes professionals engaged in diverse domains of public policy and governance, particularly in areas such as **occupational safety and health (OSH), labour inspection, social protection, social dialogue, and labour migration**.

Ideal participants include government officials, digital transformation leads, representatives of social partners, IT specialists in public service delivery, and professionals from international organizations and development agencies. The course is designed for those committed to advancing inclusive, transparent, and tech-enabled governance through the responsible adoption of digital tools and strategies.

HOW

This course consists of 60 learning hours spread across the following structure:

- **Online Phase (15 hours):** Online learning combining self-guided modules on the e-Campus platform with live sessions and expert presentations covering the foundational concepts behind digital governance.
- **Residential Phase (40 hours):** 5-day intensive training at the ITCILO in Turin with elective courses tailored to participants' professional needs, covering pressing digital challenges and emerging technologies.
- **Post-Course Assignment (5 hours):** Individual work to develop an applied project combining the learning outcomes of the course.

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
