BACKGROUND AND RATIONALE

The Maritime Labour Convention, 2006 (MLC, 2006) sets out, in a single instrument, the right of the world's 1.5 million seafarers to decent conditions of work in almost every aspect of their working and living conditions, including minimum age, employment agreements, hours of work and rest, payment of wages, paid annual leave, repatriation, on board medical care, the use of recruitment and placement services, accommodation, food and catering, health and safety protection and accident prevention, and complaint procedures for seafarers. It revises and consolidates 37 existing Conventions and related Recommendations and uses a new format with some amendments, where necessary, to ensure that the instrument remains responsive to emerging realities and to the need for continuous improvements of seafarers' rights.

As of today, the MLC, 2006 has been ratified by more than 110 countries, corresponding to closely 97% of the world gross shipping tonnage. It has been amended five times: in 2014, 2016, 2018, 2022 and 2025.

Countries that have ratified the instrument are under the obligation to report periodically on the measures taken to give effect to its provisions, in accordance with article 22 of the ILO Constitution. Employers' and workers' organizations may submit to their governments comments on the reports, or may submit comments on the MLC, 2006 application directly to the International Labour Office. Two bodies examine this information: the Committee of Experts on the Application of Conventions and Recommendations (CEACR) and the Conference Committee on the Application of Standards (CAS). On numerous occasions, these supervisory bodies have recalled that failures to fulfil reporting obligations hinder the functioning of the ILO supervisory system as a whole, and have encouraged member States to make every effort to send the reports due, to do so within the deadlines and to submit complete answers to their requests so as to allow for a thorough examination of the information provided.

The International Training Centre of the ILO (ITCILO), in collaboration with the International Labour Standards Department (NORMES), seeks to assist countries in complying with reporting obligations on the application, in law and in practice, of the MLC, 2006.

WHO IS THE TARGET AUDIENCE?

- Officials responsible for the production of reports on the application of the MLC, 2006 ("production-responsible") due under article 22 of the ILO Constitution.
- Officials with substantive responsibilities for the implementation of the MLC, 2006 who are familiar both with this sector and the employment of seafarers ("implementation-responsible").
- Representatives of employers' and workers' organizations involved in reporting and/or in the implementation of the MLC, 2006 may also benefit from the course.

The prior ratification of the MLC, 2006 by the country is required as a precondition for participation. Furthermore, for each country, it is foreseen that at least two participants (one production-responsible and one implementation-responsible) take part.

WHY SHOULD I JOIN?

To enhance the application of the MLC, 2006 by improving reporting on the steps taken by ratifying countries to apply it. By improving reporting by ratifying member States, international supervision will be improved as well, making possible a better dialogue between the ILO supervisory bodies and the State parties.

WHAT WILL I GAIN FROM THE COURSE?

- Background knowledge of the ILO, its international labour standards system and the role and operation of reporting.
- Understanding of the scope of application and content of the MLC, 2006.
- Knowledge of how to use the NORMLEX database and other resources relevant to reporting on the application of the MLC, 2006.
- Capacity to participate in the preparation of the reports on the application of the MLC, 2006 owed by ratifying member States under the ILO Constitution.

HOW IS THE COURSE ORGANIZED?

- The course runs at a distance, via Internet, and is hosted on the ITCILO E-Campus.
- Participation requires approximately 8 hours each week, which must be set aside as a part of normal work time.
- The course is based on flexible and interactive sessions, with: objectives, materials to work with and multiple-choice quizzes.
- A few live webinars will complement the self-guided sessions.
- The course includes e-coaching sessions for the preparation of a major written assignment, consisting in the drafting of portions of the report on the application of the MLC, 2006.
- A discussion forum where to engage in conversations about specific topics.
- Knowledge assessment at the start and at the end of the training.

WHAT IS THE LANGUAGE OF THE COURSE?

The course is offered in English. A good command of the working language is required.

WHO ARE THE RESOURCE PERSONS?

Tutors will follow participants' progress throughout the course. They will be supported by experts from the International Labour Office, specialists from maritime institutions and trainers from the ITCILO.

HOW MUCH DOES THE COURSE COST?

The tuition fee for the course is **1,415 Euros**.

HOW TO PAY FOR THIS COURSE?

Tuition cost must be paid in advance before the beginning of the course by the participant or the sponsor through bank transfer or credit card.

HOW TO APPLY?

The deadline for submitting applications is **10 May 2026**.

Candidates must submit through the course website the following documents:

- a letter from the sponsor indicating the financial support (or a letter from the applicant stating that participation costs are covered by him/herself), to be uploaded while filling in the on-line application.

Incomplete applications will not be considered.

Applications from employers' organizations or workers' organizations will have to be endorsed by the Secretaries of the Employers' group or of the Workers' group of the Governing Body of the ILO.

ARE THERE ANY FELLOWSHIPS?

A very limited number of fellowships are available to qualified candidates coming from eligible countries.

As an Organization dedicated to promoting social justice and internationally recognized human rights at work, the ILO is taking a leading role in international efforts to foster gender equality. In line with this ILO focus, women are particularly encouraged to apply to ITCILO courses.

WITHDRAWAL, CANCELLATION POLICY, AND REFUNDS FOR OPEN COURSES

If an enrolled participant wishes or must withdraw from a course, they may choose to apply to a different course or be substituted by another candidate. The participant must notify the Centre, in writing, of their decision at least 14 days prior to the start date of the course. Cancellation of participation in regular courses will result in the following penalties:

- 14 days or more prior to the start date of the course: No penalty, 100% refund of amount paid less applicable bank charges
- 8 to 13 days prior to the start date of the course: Penalty of 50% of course price, refund of residual amount paid (if any) less applicable bank charges
- 7 days or less prior to the start date of the course: Penalty of 100% of course price.
